

AGREEMENT ENTERED INTO BY AND BETWEEN CLUB MEMBERS AND THE CLUB.



,	(please	print	in
capitals) the undersigned, do hereby agree as follows:			

- I incorporate herein by reference the document titled: "RELEASE OF LIABILITY, ASSUMPTION OF RISK, CONSENT TO INJURY & INDEMNITY" (hereinafter be referred to as "the Indemnity") and I acknowledge that I am bound by the terms thereof.
- 2. I shall not be entitled to be or become a member of the club and/or participate in any club activity unless I have duly signed and completed the above agreement.
- 3. This agreement shall endure for the benefit of the club and its members for as long as I remain a member of the club and also subsequently if I should at any stage after the termination of my membership of the club, become a guest of the club or a member of the club.
- 4. I shall not be entitled to invite any person (hereinafter referred to as my "guest") to participate in any club activity whatsoever unless I have ensured that such guest had at the earliest opportunity signed the Indemnity and I had handed the duly completed Indemnity to the appropriate office-bearer of the club.
- 5. Unless I abide by the terms and conditions set out above -
 - 4.1. My guest/s shall not be permitted to lawfully participate in any club activities.
 - 4.2. I shall be personally liable for any harm which might befall my guest/s.
 - 4.3. I shall remain personally liable to the club and my guest in every respect as if my guest had duly concluded the Indemnity agreement with me in my personal capacity and not with the
 - 4.4. I hereby agree to absolve, waive, release, hold blameless and indemnify the club members from any harm which may befall my guest/s and I will at my own expense and volition defend any application, action or claim which may be asserted by my guest against the Club or its members
- 5. I agree that if my guest is under 18 years of age (hereinafter referred to as the "minor"), I shall ensure that his parent/natural guardian shall duly complete and sign this Indemnity on his/her behalf.
- 6. I warrant that the person who signs on behalf of the minor is the parent and/or natural guardian of the minor guest and that he/she is legally competent to sign the Indemnity on behalf of the minor guest.
- 7. Unless one or more of the parents or the minor's natural guardian signs the Indemnity on behalf of my minor guest, I warrant that, and there will be an irrebuttable presumption, that all my guests are 18 years of age or older.
- 8. No concession, indulgence or failure to strictly enforce compliance with any term or condition of this Indemnity shall be construed as a waiver of any rights of the club or to restrict or prohibit the club in any way from strictly enforcing all its rights at any time.
- 9. I shall at all times be personally liable to the club for all acts and/or omissions of my guest/s and/or for all or any harm which might be caused by my guest/s.
